Many people believe that integrated reports are kinds of combination of annual reports and sustainability reports. Most sustainability consulting firms are providing improper knowledge seminar for industrial report preparers since publication of this draft because they don't understand integrated reporting. Nevertheless the framework has discussed the objective of <IR> and how <IR> interacts with other reports and communications, many people are misunderstood. Therefore, I do think that IIRC should make an effort to complement the overview of the framework which includes definition, objective of <IR> and interaction with other reports. I recommend that the framework would discuss examples of misuse of the framework.

Interaction with other reports and communications

The <IR> process is intended to be applied continuously to all relevant reports and communications, in addition to the preparation of an integrated report. The integrated report may include links to other reports and communications, e.g., financial statements and sustainability reports. The IIRC aims to complement material developed by established reporting standard setters and others, and does not intend to develop duplicate content (paragraphs 1.18-1.20).

Chapter 2: Fundamental concepts

The capitals (Section 2B)

The Framework describes six categories of capital (paragraph 2.17). An organization is to use these categories as a benchmark when preparing an integrated report (paragraphs 2.19-2.21), and should disclose the reason if it considers any of the capitals as not material (paragraph 4.5).

Business model (Section 2C)

A business model is defined as an organization’s chosen system of inputs, business activities, outputs and outcomes that aims to create value over the short, medium and long term (paragraph 2.26).

Outcomes are defined as the internal and external consequences (positive and negative) for the capitals as a result of an organization’s business activities and outputs (paragraphs 2.35-2.36).
