Chapter 1: Overview

Principles-based requirements

To be in accordance with the Framework, an integrated report should comply with the principles-based requirements identified throughout the Framework in bold italic type (paragraphs 1.11-1.12).

Interaction with other reports and communications

The <IR> process is intended to be applied continuously to all relevant reports and communications, in addition to the preparation of an integrated report. The integrated report may include links to other reports and communications, e.g., financial statements and sustainability reports. The IIRC aims to complement material developed by established reporting standard setters and others, and does not intend to develop duplicate content (paragraphs 1.18-1.20).

2. Do you agree with how paragraphs 1.18-1.20 characterize the interaction with other reports and communications?

3. If the IIRC were to create an online database of authoritative sources of indicators or measurement methods developed by established reporting standard setters and others, which references should be included?

4. Please provide any other comments you have about Chapter 1.

Objectives of <IR> (art. 1.3) miss the point concerning creation of a single document format that would satisfy the need to integrate financial and non-financial reporting information. The status of <IR> as a document is not described now – whether it would be mandatory reporting document for large companies (like Annual Report)? It is in the Draft that the main audience of <IR> will be investors (providers of financial capital). However, one of the key concepts - Capitals - states that some capitals are co-owned by company and its stakeholders (various stakeholders). And here is the contradiction: company's activities affect various group of stakeholders, however it accounts for it only to one group (investors). We would suggest making adjustments to this point.

Chapter 2: Fundamental concepts

The capitals (Section 2B)

The Framework describes six categories of capital (paragraph 2.17). An organization is to use these categories as a benchmark when preparing an integrated report (paragraphs 2.19-2.21), and should disclose the reason if it considers any of the capitals as not material (paragraph 4.5).

5. Do you agree with this approach to the capitals? Why/why not?

Yes, we agree with the general approach to the capitals.

6. Please provide any other comments you have about Section 2B?

Business model (Section 2C)

A business model is defined as an organization's chosen system of inputs, business activities, outputs and outcomes that aims to create value over the short, medium and long term (paragraph 2.26).

7. Do you agree with this definition? Why/why not?

Yes, we agree with the general defenition of business model.

Business model (Section 2C) continued

Outcomes are defined as the internal and external consequences (positive and negative) for the capitals as a result of an organization's business activities and outputs (paragraphs 2.35-2.36).

8. Do you agree with this definition? Why/why not?

9. Please provide any other comments you have about Section 2C or the disclosure requirements and related guidance regarding business models contained in the Content Elements Chapter of the Framework (see Section 4E)?

Chapter 3: Guiding Principles

Materiality and conciseness (Section 3D)

Materiality is determined by reference to assessments made by the primary intended report users (paragraphs 3.23-3.24). The primary intended report users are providers of financial capital (paragraphs 1.6-1.8).

11. Do you agree with this approach to materiality? If not, how would you change it?

Materiality determination process should include dialogues with stakeholders.

12. Please provide any other comments you have about Section 3D or the Materiality determination process (Section 5B).

Reliability and completeness (Section 3E)

Reliability is enhanced by mechanisms such as robust internal reporting systems, appropriate stakeholder engagement, and independent, external assurance (paragraph 3.31).

13. How should the reliability of an integrated report be demonstrated?

Public assurance can be used as a tool to ensure the quality of the <IR> and the implementation of the "stakeholder responsiveness" principle.

14. Please provide any other comments you have about Section 3E.

15. Please provide any other comments you have about Chapter 3 that are not already addressed by your responses above.

It is necessary to draw a clear distinction between the principles and the content elements. Now they merge in some cases, so it is somewhat difficult to use them (see the principle "strategic focus and future orientation" and elements "strategy and resources allocation plans" and "Future outlook"). It would be better, if version 1.0 provided clear instructions as to how the principles overturn to content elements.

Chapter 4: Content Elements

16. Please provide any comments you have about Chapter 4 that are not already addressed by your responses above (please include comments on the Content Element Business Model [Section 4E] in your answer to questions 7-9 above rather than here).

It would be better to include a typical structure (annotated table of contents) of an integrated report in Version 1.0. Now it is not clear whether Content Elements are sections/chapters of the report or not?

Chapter 5: Preparation and presentation

Involvement of those charged with governance (Section 5D)

Section 5D discusses the involvement of those charged with governance, and paragraph 4.5 requires organizations to disclose the governance body with oversight responsibility for <IR>.

17. Should there be a requirement for those charged with governance to include a statement acknowledging their responsibility for the integrated report? Why/why not?

18. Please provide any other comments you have about involvement of those charged with governance (Section 5D).

Credibility (Section 5E)

The Framework provides reporting criteria against which organizations and assurance providers assess a report's adherence (paragraph 5.21).

19. If assurance is to be obtained, should it cover the integrated report as a whole, or specific aspects of the report? Why?

20. Please provide any other comments you have about Credibility (Section 5E). Assurance providers are particularly asked to comment on whether they consider the Framework provides suitable criteria for an assurance engagement.

The Framework should contain a requirement to ensure the reliability of data (audit) and the guidance for its conduct.

21. Please provide any other comments you have about Chapter 5 that are not already addressed by your responses above (please include comments on the materiality determination process [Section 5B] in your answer to question 11 above rather than here).

The Framework should provide clear guidance as to what the minimum of the financial information has to be disclosed in the report.

One can think about the implementation of a system of gradual improvement of quality (see GRI Levels of application). Another proposal in the spirit of GRI is the development of industryspecific applications.

Recognizing that <IR> will evolve over time, please explain the extent to which you believe the content of the Framework overall is appropriate for use by organizations in preparing an integrated report and for providing report users with information about an organization's ability to create value in the short, medium and long term?

Development of <IR>

The form of Integrated Report should be prescribed in the Framework: one or several related documents.
