

#### Interaction with other reports and communications

The <IR> process is intended to be applied continuously to all relevant reports and communications, in addition to the preparation of an integrated report. The integrated report may include links to other reports and communications, e.g., financial statements and sustainability reports. The IIRC aims to complement material developed by established reporting standard setters and others, and does not intend to develop duplicate content (paragraphs 1.18-1.20).

The Framework describes six categories of capital (paragraph 2.17). An organization is to use these categories as a benchmark when preparing an integrated report (paragraphs 2.19-2.21), and should disclose the reason if it considers any of the capitals as not material (paragraph 4.5).

5. Do you agree with this approach to the capitals? Why/why not?

I partly agree.

Intellectual capital is the outcome of others at times. In my opinion, I think both of Intellectual and Social and relationship capital belong to the Organization. Intellectual capital is inner capital while Social and relationship capital is to the outside entities.

### Business model (Section 2C)

A business model is defined as an organization's chosen system of inputs, business activities, outputs and outcomes that aims to create value over the short, medium and long term (paragraph 2.26).

Outcomes are defined as the internal and external consequences (positive and negative) for the capitals as a result of an organization's business activities and outputs (paragraphs 2.35-2.36).

The Framework provides reporting criteria against which organizations and assurance providers assess a report's adherence (paragraph 5.21).

Unless the integrated report become mandatory, to include it into assurance would defer the willingness of adoption. Reporting activities in Japan are quite heavy already. It will be better to encourage them to use integrated reporting as the tool to communication with diversified stakeholders.
