Sectin 1.10 points out, that the Framework is intended for application by a.o. for-profit companies of any size. In our view the Framework has been designed for large companies, PIE's in particular. We strongly believe that, in order to develop a relevant Framework for SME's, a separate exercise should be undertaken. This exercise should adequately involve relevant stakeholders from the SME-community. Amongst others it should be considered whether the development of a Framework should be limited to larger SME's, thus omitting smaller ones. In considering the development of such a Framework for SME's it could prove worthwile to include different SME's of different size in the pilot of the present Framework.

In view of this key comment we have abstained from comments on particular elements of the Framework.

Chapter 2: Fundamental concepts

The capitals (Section 2B)

The Framework describes six categories of capital (paragraph 2.17). An organization is to use these categories as a benchmark when preparing an integrated report (paragraphs 2.19-2.21), and should disclose the reason if it considers any of the capitals as not material (paragraph 4.5).
