Materiality is determined by reference to assessments made by the primary intended report users (paragraphs 3.23-3.24). The primary intended report users are providers of financial capital (paragraphs 1.6-1.8).

No. Materiality is also related to the impacts the organisation has on the impacted parties / external stakeholders, through the daily activities of the organisation. They should assess the materiality as they see it daily. The providers of financial capital do not.

Focusing on the providers of financial capital can be dangerous as it gives the impression that they are the most important stakeholder. It reinforces the perception that their angle of view is the right one to assess the societal added-value of an organisation.

Reliability is enhanced by mechanisms such as robust internal reporting systems, appropriate stakeholder engagement, and independent, external assurance (paragraph 3.31).
