Key Points

A key point that we want to emphasize is the focus on the providers of financial capitals as primarily users of the IR report. The IR report should respond to all KEY stakeholders, paying particular attention to providers of financial capitals.

To ensure that this IR approach is suitable also for SME's we suggest to develop ad hoc version.

Another key point are related to assurance and materiality (see comments below)

Chapter 1: Overview

Principles-based requirements

To be in accordance with the Framework, an integrated report should comply with the principles-based requirements identified throughout the Framework in bold italic type (paragraphs 1.11-1.12).

1. *Should any additional principles-based requirements be added or should any be eliminated or changed? If so, please explain why.*

Interaction with other reports and communications

The <IR> process is intended to be applied continuously to all relevant reports and communications, in addition to the preparation of an integrated report. The integrated report may include links to other reports and communications, e.g., financial statements and sustainability reports. The IIRC aims to complement material developed by established reporting standard setters and others, and does not intend to develop duplicate content (paragraphs 1.18-1.20).

2. *Do you agree with how paragraphs 1.18-1.20 characterize the interaction with other reports and communications?*

We are agree, but we suggest more direct link with others international references. See next question

3. *If the IIRC were to create an online database of authoritative sources of indicators or measurement methods developed by established reporting standard setters and others, which references should be included?*

We recomend: GRI + ISO 26000 + Global Compact + IFC standards.
For financial reports: IFR

Chapter 2: Fundamental concepts

The capitals (Section 2B)

The Framework describes six categories of capital (paragraph 2.17). An organization is to use these categories as a benchmark when preparing an integrated report (paragraphs 2.19-2.21), and should disclose the reason if it considers any of the capitals as not material (paragraph 4.5).

5. *Do you agree with this approach to the capitals? Why/why not?*

In general we agree, but it is necessary to improve the capital's concept with more realistic examples.

6. *Please provide any other comments you have about Section 2B?*

The most difficult concept to understand was Intellectual Capital. In Human Capital we miss Health and Safety issues.

Business model (Section 2C)

A business model is defined as an organization's chosen system of inputs, business activities, outputs and outcomes that aims to create value over the short, medium and long term (paragraph 2.26).

7. *Do you agree with this definition? Why/why not?*

We agree, but it's important in relation with the value creation process and capitals to highlight the potential impacts (positive or negative) on others stakeholder's capitals.

Business model (Section 2C) continued

Outcomes are defined as the internal and external consequences (positive and negative) for the capitals as a result of an organization's business activities and outputs (paragraphs 2.35-2.36).

8. *Do you agree with this definition? Why/why not?*

We agree

More detailed guidance is needed in the issue "connection to information in other Content Elements, such as strategy, opportunities and risks, and performance..."

Chapter 3: Guiding Principles

Materiality and conciseness (Section 3D)

Materiality is determined by reference to assessments made by the primary intended report users (paragraphs 3.23-3.24). The primary intended report users are providers of financial capital (paragraphs 1.6-1.8).

11. *Do you agree with this approach to materiality? If not, how would you change it?*

We recommend be more explicit on the relevance to involve providers of financial capital in the materiality process and ways to involve them.

12. Please provide any other comments you have about Section 3D or the Materiality determination process (Section 5B).

Reliability and completeness (Section 3E)

Reliability is enhanced by mechanisms such as robust internal reporting systems, appropriate stakeholder engagement, and independent, external assurance (paragraph 3.31).

13. How should the reliability of an integrated report be demonstrated?

The best way to demonstrate the reliability (including cost / benefit) it will be a self assurance system, based on international standards.

In this case it will be necessary to develop an assurance guidance standard.

Chapter 4: Content Elements

It will be difficult to describe "the magnitude of the material trade-offs that influence value creation overtime" (4.5)

Chapter 5: Preparation and presentation

Involvement of those charged with governance (Section 5D)

Section 5D discusses the involvement of those charged with governance, and paragraph 4.5 requires organizations to disclose the governance body with oversight responsibility for <IR>.

17. Should there be a requirement for those charged with governance to include a statement acknowledging their responsibility for the integrated report? Why/why not?

We agree. This will demonstrate commitment and support from the highest body of the company.

18. Please provide any other comments you have about involvement of those charged with governance (Section 5D).

Credibility (Section 5E)

The Framework provides reporting criteria against which organizations and assurance providers assess a report’s adherence (paragraph 5.21).

19. If assurance is to be obtained, should it cover the integrated report as a whole, or specific aspects of the report? Why?

It will be very complex to obtain the assurance as a whole. We should use our internal assurance system as much as possible and in the cases of uncovered areas, and external assurance will be necessary.
